River Restoration Meetings to be Held August 6th

July 21, 2015



(Oakland, IA) – Iowa Rivers Revival is collaborating with Golden Hills RC&D to host educational presentations in Emerson and Walnut about river restoration on Thursday, August 6th. Landowners, farmers, conservationists, educators, and the public are invited to attend one of the two free meetings:

- 1:00-3:00pm at the Emerson Community Building – 701 Morton Ave. Emerson, IA 51533
- 6:00-8:00pm at the Walnut Welcome Center – 607 Highland Street Walnut, IA 51577

These meetings will build on the river restoration meetings held throughout Southwest Iowa in June, but will also include technical experts who can answer questions about implementing river restoration practices. Speakers will include:

- John Thomas, Project Director with the Hungry Canyons Alliance, will discuss the history of Western Iowa stream stability and local river restoration projects;
- Roz Lehman, Executive Director of Iowa Rivers Revival, will discuss Iowa Rivers Revival's programs and policy efforts;
- Claire Rhuby with the Iowa Department of Natural Resources will discuss river restoration projects in Iowa;
- Karen Smith with the Iowa Department of Natural Resources will discuss the permitting process for streambank stabilization and river restoration projects.

River restoration benefits taxpayers by reducing infrastructure costs associated with streams eroding into roads and bridges. Aquatic and riparian wildlife habitat can also improve with river restoration. River recreation, fishing, and hunting, which contribute hundreds of millions of dollars to Iowa's economy, also benefit from river restoration. These benefits in turn help improve public health and quality of life.
